#### **Director's Report**

2. Manager's Report – Drew Florence, Richland Assistant City Manager/BCES Director SECOMM currently has 14.5 positions open. Five have received and accepted conditional offers and are awaiting final physical, psychological and backgrounds to complete the hiring process. Three additional prospects are in progress.

Text-To-911 will have a soft start on August 2, 2022. Texting will be rolled-out to the public on September 11, 2022. Staff identified an issue with android phones in that location information is not received. This issue, originally thought to be limited to our implementation was discovered to be statewide. Testing continues.

Communications Supervisor Aimee Fournier-Plante has been selected to represent Eastern Washington on the Washington State Public Safety Telecommunicator Certification Board.

Communications Supervisor Gwen Stanley has been promoted to Communications Manager. She will work closely with SECOMM staff. Communications Manager Kim Lettrick will continue to oversee administrative tasks. Duties are still being solidified.

The Board was briefed on recent vandalism and theft from our communications sites. Fencing was cut and radio frequency antenna's ground copper busbar and grounding antennas were stolen. A report has been filed with Benton County. Repairs have since been made.
