Director's Report

 Manager's Report – Drew Florence, Richland Assistant City Manager/BCES Director SECOMM currently has 15 open positions with 2 pending departures in the coming weeks. A third may also be leaving for a job in Othello but may stay on as part-time.

Statistical information shows the majority of calls coming into dispatch are non-emergency. Future discussions with law enforcement are planned in efforts to reduce the number of administrative, non-emergency calls. Drew Florence has already had conversations with Fire Chiefs and Sheriffs about changes to levels of service.

Items of Business

Benton County Emergency Services (BCES)

3. Vote to Affirm Hire of Benton County Emergency Services Executive Director Background, polygraph, psyche and medical investigations have been completed for the Executive Director candidate, Jeremy (Jay) Atwood. Jay comes to us from the Spokane Fire Department where he is currently the Deputy Chief of Support Services. His anticipated start date is September 19th or 26th.

Drew Florence recommended the BCES Executive Board vote to affirm the hire (a necessity of the interlocal agreement) of Jeremy Atwood as the Benton County Emergency Services Executive Director.

RON DUNCAN MADE THE MOTION TO AFFIRM THE HIRE OF JEREMY ATWOOD AS BENTON COUNTY EMERGENCY SERVICES EXECUTIVE DIRECTOR. KEITH JOHNSON SECONDED THE MOTION. ALL WERE IN FAVOR. MOTION CARRIED 13-0.

Jon Amundson thanked the Board for their participation in the interview process. He also thanked Drew Florence for leading the recruitment process.

Benton County Emergency Management (BCEM)

4. DR-4650 Hazard Mitigation Grant Program Application – Designation of Applicant Agent and Letter of Intent to Participate and Commit Matching Funds

Deanna Davis explained that when a disaster happens in the state and it goes presidential, a certain percentage of the actual payout of the grant of that declaration goes into the Hazard Mitigation Grant Program. This provides an opportunity to apply for hazard mitigation funds. We are looking for money to update our Hazard Mitigation Plan that is due in 2024.

For the process of providing an application back to the state, a designated applicant must be identified for the state to coordinate with. The letter of intent to participate guarantees the applicant is aware of the match that is required to the grant. The match for this grant is typically 75/25 but this grant was discovered to be a 90/10 split - 90% is federally funded and 10% is funded through the state. The state then splits that with the local jurisdiction, each paying 5%. The Hazard Mitigation Plan is a critical component that allows jurisdictions to apply for project funding. Without an approved Hazard Mitigation Plan, some jurisdictions would not qualify to request project funding.

JEROME DELVIN MOVED AND MARIE MOSLEY SECONDED THE MOTION TO APPROVE DR-4650 HAZARD MITIGATION GRANT PROGRAM APPLICATION –

DESIGNATION OF APPLICANT AGENT AND LETTER OF INTENT TO PARTICIPATE AND COMMIT MATCHING FUNDS. ALL WERE IN FAVOR. MOTION CARRIED 8-0.

Discussion Items

- Red Mountain Road Update
 - Jerome Delvin said an update has been received from Paul Knutzen who has been hired to design the road on Red Mountain. Mr. Knutzen hopes to have everything wrapped up (including permitting) by December after which it can be put out for bid. Mr. Knutzen spoke with landowner Gary Heaton and his siblings who have all agreed to allow the road to pass through all three of their parcels. This will reduce the number of switchbacks thus reducing the overall costs.
- VHF Radio Governance Options

Tom Huntington spoke on the condition of the VHF system and the need to establish a governance structure in order be eligible to apply for grant funding to pay for a VHF system upgrade. The preferred path would be to bring the VHF system back under BCES. If the Board was willing to consider this, a draft mechanism to make that happen would be brought back for further consideration. The other option would be to create an interlocal agreement agency but with approximately 19 stakeholders and their respective boards, the time to do so is very short as the FEMA grant period opens in January.

He also noted that Deanna Davis has helped secure grant funding for an engineering study including system evaluation, system design and other core pieces that allow positioning for future grant applications. An RFQ process just closed after receiving 4 vendor submittals for the study which will be reviewed next week.

A general consensus of the Board agreed to move forward with the VHF system being brought back under BCES governance.

Capital Funding Sources/Priorities

Capital funding needs for BCES are estimated at \$15 - \$20 million dollars. A phased approach will allow some progress to be made. VHF and Microwave are estimated at \$7 - \$9 million dollars alone and are considered the most pressing.

The City of Kennewick is working on a proposal to re-engage Sciens to develop a capital plan. The City of Richland is working on an RFQ to identify a grant writer that can operate on behalf of both the city and BCES. Jon Amundson clarified that there are no specific grants currently targeted and that the grant writer would identify and seek available grants as part of their position. BCES staff is working on a prioritized list based on currently known capital needs.

Potential financing of some capital items (VHF, Microwave and other items to be identified) through the state's local government loan program are being looked at. There is also ample

fund balance to cover several immediate needs, or they could be included in the 2023 budget and allocated out. Jerome Delvin added there could be an additional \$2 million dollars (for Microwave) in federal funding come October. A more detailed list and action items will be presented at next month's meeting.

Marie Mosley added that long term needs from a consolidated perspective for Bi-PIN and BCES should be included as the intent is to eventually combine the two entities. Jon Amundson agreed, adding that a timeline and project planning would occur and would include both Bi-PIN and BCES capital needs as they relate to further integration of the systems. The timing of when to merge the two Boards is a discussion needing to be had with both BCES and Bi-PIN Boards.

• Strategic Advisory Team

The reason dispatch personnel are leaving is due to the number of hours being worked with mandatory overtime. Some changes will need to be made to the level of service which will result in things being significantly different than they have been for Law in the field. It will push more onto the officers and police departments. These changes should have little impact to Fire if any. Online reporting software that would allow non-emergency, no suspect type calls to be routed is also being looked at.

Drew Florence will send an email to Chiefs and Sheriffs regarding changes. Fire is welcome to participate although it is doubtful they would be impacted. Drew Florence noted the Inter-Local Agreement (ILA) is very specific in that it is made up of Chiefs and Sheriffs and an executive from Prosser. He suggested users in the field who are able to make decisions on behalf of their respective agencies attend this discussion.

• Recruitment

Brent Gerry questioned recruitment and retention strategies. Drew Florence noted that we are not struggling with attracting applicants as we have 8 in different phases of background and he expects a couple of final offers to be made soon.

Oral board interviews are being eliminated which may result in exercising probationary terminations more often, but it may also result in getting a few more hires made. Statistics for our target age group (18 - 25) show that 90% use YouTube as their primary information source. Recruitment efforts at schools are being stepped up and a new recruitment video using both Law and Fire may be produced. We also have a lateral candidate in the process. Some ideas about recruitment will be worked on and presented in the coming months.

Southeast Communications (SECOMM) – Kim Lettrick

<u>Staffing</u> SECOMM has 17 open positions.

August 2022 Statistical Information 9-1-1 Calls = 12,153 Text to 911 = 12 Non- Emergency = 17,197 Law Enforcement Events = 26,642 Fire/EMS Events = 3,722

<u>Telecommunicators Joining the Public Safety Employees' Retirement System (PSERS)</u> Senator Van De Wege has begun the legislative effort to move Public Safety Telecommunicators to the PSERS system. The effort is being led by Teamsters at this time with updates being provided from our APCO lobbyist.

Recruitment Update

COR Human Resources continues to activity engage in recruitment advertising including coordinating with local jurisdictions to provide recruitment information on their social media and web sites.

SECOMM staff continue to take every opportunity to attend recruitment events and other public education events that allow us to share recruitment information.

The Washington State 911 office began an initiative titled "Fully Resourced 911". The first step is coordinating an effort to develop statewide recruiting events. The first event will be held in Pierce County in October of this year. All PSAPs are welcome to join and/or observe the event. After the initial event we will evaluate the success and develop plans for other events across the state.

<u>Text to 911</u>

Public announcement of Text to 911 service occurred on September 11, 2022. The City of Richland's Marketing Department assisted with a public education effort that included interviews, recorded PSAs and social media material.

Southeast Communications (SECOMM) – Gwen Stanley

Operations

Since August 23rd, the management group has covered 126 hours of overtime that would have been mandated. This also includes shifts that were below minimum staffing.

A new schedule was implemented September 12th and staffing levels were adjusted. This has resulted in 128 hours of overtime that was not mandated to be worked thus far.

Benton County Emergency Management (BCEM) – Deanna Davis

<u>Planning</u>

The Radiological Emergency Preparedness (REP) plan has met all Federal Emergency Management Agency (FEMA) planning standards and FEMA has accepted the Benton County REP plan as our new plan of record. The REP plan will be brought before the BCES Executive Board for approval during the October meeting.

A big thank you to our municipal partners – I recently made a request to city and county staff for assistance with several surveys. The surveys were a product of the state office of Emergency Management and were designed to capture our level of preparedness and or gaps as it relates to the National Preparedness Goal's 32 Core Capabilities. Since I am not the subject matter expert for all 32 core capabilities I needed the assistance of our partner agencies from law enforcement, fire, public works, transportation, mortuary services, medical services, and others to extend a sincere thank you for their efforts. Ultimately the information provided will feed a report the state will send to the Governor regarding the "preparedness" of the state and our community.

<u>Exercise</u>

September 13th was the "dress rehearsal" drill for the Columbia Generating Station and the first test of our new REP Plan and procedures. While this was just a practice drill in preparation for the FEMA Evaluated Exercise to take place on October 25, 2022, the FEMA evaluators had favorable comments regarding our ability to provide for the health and safety of the public if there were ever a radiological emergency.

Benton County Emergency Services Information Systems (BCES IS) - Doug deGraaf

GIS/SECOMM

Map roll 149 went live with 200 new address points and 22 additional/extended road segments. The road list used by all agencies dispatched by SECOMM has been updated and uploaded to the BCES website. New unique street names were updated in Locution so they are pronounced properly. Boundary layers were created for Benton County Emergency Management (BCEM) to be used in Columbia Generating Station (CGS) and Department of Energy (DOE) emergencies.

BCES GIS/CAD Technician, Michael Mendez has been trained to create new CAD accounts and reset/unlock accounts.

BCES Tech Systems Coordinator, Craig Hamilton worked with CryWolf to resolve an issue with alarm data being sent to their systems. Craig has also been working with the fire agencies to implement new Event Types into CAD.

The Hexagon CAD 9.4 kickoff meeting was held on August 30^{th} where expectations and timelines were provided for the upgrade. SQL (Database) configurations have been completed as of September 8^{th} . Hexagon will be installing the server software and converting our current database to the new version (9.4) soon. The Kickoff presentation and meeting minutes are attached for review.

800MHz/P25/Microwave

Motorola completed infrastructure security updates to the 800MHz system on 8/31 and 9/1/2022. These security updates will take place every quarter going forward.

BCES, Benton County, Adcomm and Sabre have met to go over the tower and shelter construction expectations and contracts. We discussed the need for the road to be included in the National Environmental Policy Act (NEPA) and outcomes with the Umatilla Tribes, the road must be completed prior to the General Contractor starting work and for the tower and shelter to be delivered. Benton County is in the process of completing the engineering before they contract the road construction. The current delivery date for the shelter is expected to be June 2023, the tower will be delivered near the same time as the shelter.

<u>BCES</u>

The September security patches have been applied.
